'Pink Finance was also part of the expert working group that led to the introduction of Life Assurance for HIV Positive people. We are currently campaigning for cheaper and fairer premiums for HIV Positive people taking out Life Assurance'.

The new re-launched Pink Finance is keen to hear from anyone who feels they have been treated unfairly by the financial services industry due to their sexuality, health status, marital status, employment status or credit history.
